

MINUTES OF ERLESTOKE PARISH COUNCIL MEETING **23rd October 2008**

Present: Councillors, Mr. S. Jonik (Chairman), Mr. A. Pinnington (Vice Chairman), Mr. M. Gilbert, Mr. R.L. Smith, Mrs. D. Oram and Mrs. A. Whittle (Clerk).

Open Forum:

Mr R Hampton. Mr Hampton addressed the council regarding the recent discussions about spending money on the secret garden. He feels that the money would be better spent in other ways around the village specifically on the possible alterations to the church to make it into a community hall. The church council want to hold a meeting with the Village Hall Committee and the Parish Council to discuss the best way to move forward to get a meeting place in the village.

PC Lamden – Community Beat Manager Devizes South Rural. PC Lamden spoke to the council on various issues. She explained who her team were, Nina Marsh, Fiona Marnow and Amanda Parkes. As there had recently been changes to the Police areas a leaflet was being printed which will be circulated giving contact details etc. Roger Hampton complemented the Police on their actions during a recent possible incident at a resident's home in the village. Cllr Pinnington asked if the driver training course could be changed as the police cars travel along Lower Road very fast when on training and the road is not suitable for such speed. PC Lamden advised that she would speak to Inspector Andrew Noble who is in charge of the driver training.

131/08 Building without planning permission

A complaint had been received about building going on without planning permission. The clerk was asked to place a notice in the News as follows: The Parish Council reminds residents of Erlestoke that they are to adhere to all up to date planning and building regulations and should seek advice from the planning office at Kennet District Council on 724911 before commencing any building.

132/08 Ongoing items – update reports

1. **Rebound Wall.** The rebound wall has now been fitted and is being used on a regular basis by the children and parents of the village.
2. **Seat outside church.** The request for a seat over 7ft outside the church can only be met by purchasing two seats and having them fitted side by side. The council resolved to have the 5ft seat already purchased installed and should another seat be required in the future they would purchase as needed.

The clerk will notify the supplier and get the seat installed.

3. **Seat around hornbeam tree.** This is due to be fitted during November.
4. **Car Park in The park area.** Cllr Jonik explained that he had spoken to Cllr Grundy about this who had advised a letter be sent to Kennet asking for help with funding. As yet no reply had been received.
5. **SSEB Sub Station.** Nothing to report at present.

133/08 Footpaths and Highways - including damage to the road through The Park

Cllr Jonik had spoken to Clarence at Wiltshire County Council advising them of the damage to the road through the Park. This is now in highways hands to take forward.

134/08 Recycling Skips

Cllr Jonik explained that there had obviously been confusion this year about booking the skips etc but the village is definitely on the list for next year. The council asked that either a letter or email be sent in January 2009 asking when the skips would be on site. It has been suggested that we could coordinate with Great Cheverell so that we get the skips the same day as they do. The clerk will diarise this for January.

135/08 Possible appointment of Village handyman

It was decided by the council to review this after April 2009 when the new unitary council comes into effect.

136/08 Community Hall – meeting of the Village Hall Committee, Parochial

Church Council and the Parish Council to discuss the possibility of the Church becoming a community hall and the funding of such a project. The council resolved to work alongside the two organisations regarding a possible community hall.

Devizes Town Council – Asking if Erlestoke would be interested in taking ownership of various items of redundant skate park equipment.

The clerk was asked to write thanking the council for its offer but Erlestoke are not in a position to take up the offer.

140/08 To receive reports from Village Representatives

Cllr Oram. Cllr Oram reported that highways had cleared the weeds away from the red brick wall in Lower Road. She had spoken to the footpath officer about cutting back the footpath to Coulston. The clerk was asked to email Esther Daly about this path.

Cllr Loraine-Smith. Could the clerk email Rod Gibbs Replacement, as he has retired, to advise him of the promised work to the footpaths.

Cllr Jonik. The drain opposite Beech house is blocked. Cllrs Loraine-Smith and Oram will deal with this through the Parish Steward.

141/08 Co-option of a new Councillor – Close advert and arrange interview date

Cllr Jonik explained that three applications had been received for the vacant post. He had been advised after the previous cooption that an interview process should take place as there is more than 1 applicant. The clerk agreed to write to the three candidates asking them to attend a short interview at the Church on 2nd of December 2008. A decision will then be taken at the next Parish Council meeting on the 4th of December 2008.
