## 5.3 Erlestoke Crossing CATG issue 5067 (School Crossing)

Members are requested to consider whether to agree to make a 25% contribution to the proposed scheme. £1,026.25 = 25% of the cost. Email from Graeme Morrison below explains the proposals.

It may be worth making an application to the Area Board for some of this cost.

The proposed scheme includes:

- New "SLOW" road markings in 2 x locations on the approach to the village from the direction of the prison entrance
- Removal of the "road narrowing, sharp right-hand bend and "REDUCE SPEED NOW"" sign
- Above sign to be replaced by 2 x signs:
  - o 1 x "S" bend and "REDUCE SPEED NOW" sign
  - o 1 x road narrowing and "ONCOMING VEHICLES IN MIDDLE OF THE ROAD" sign
- New road narrowing and "ONCOMING VEHICLES IN THE MIDDLE OF THE ROAD" sign for vehicles approaching the area from Edington direction
- Removal of centre warning lines on road throughout the "S" bend
- Additional edge of carriageway lines through same stretch as above
- Refresh of give way markings

The quote we have got for these works is £4,105.00 Although the parish council originally suggested they would pay for the installation as a sign, this obviously has a lot higher cost involved, so we would treat it as a normal CATG proposal, for which we would usually expect a PC contribution of 25% of the cost.

I have copied Stan Jonik into this email as well – I hope that is ok.

As discussed if you could let us know the parish council's thoughts on this once you have discussed it I will take the response to the next CATG meeting.

#### **282/17** MINUTES

Not enough Councillors were present from the previous meeting to approve the accuracy of the minutes. It was agreed that the minutes of the meeting held on Wednesday 6 December 2017 would be presented for approval at the next meeting scheduled for Wednesday 21 February 2018.

# 283/17 REPORT FROM COUNCILLOR RICHARD GAMBLE – WILTSHIRE COUNCIL

The next Area Board Meeting was scheduled for Monday 22 January 2018 and will take place at Lavington School, starting at 6.00pm with refreshment for a 6.30pm start.

Topics for discussion would include Devizes Development Partnership's plans to open a railway station at Lydeway.

Councillor Gamble advised members that the Parking Consultation over the proposed increase in parking charges had now completed. The results suggest that respondents agreed to the increase in charges which were in line with inflation. The monies from parking charges do go towards supporting the rural buses, and essential service in remote communities.

Councillor Gamble was in correspondence from Vodaphone working with Telephonica in regards to improving their mast which is adjacent to the railway between Erelestoke and Littleton Panel. It is hoped that this would give Erlestoke a better service.

Councillor Gamble reported that a 'Men's Shed' would be opening in Devizes. However, it would be open to all genders. It will be located behind Needham House in Victoria Road. And opening on 25 January 2018. It is great for simple DIY enthusiasts and offered a good opportunity to meet people who otherwise might be isolated. The Area Board has grant funded the project.

A new PCSO has just started in Erlestoke. The local Police are particularly interested in activities on the Plain as reporting is not as it should be. They are Interested to her from farmers in the area especially with reports of Hare Coursing and other illegal activities.

Councillor Lewcock advised Councillor Gamble of the poor reporting of road closures he explained that in some cases the closure did not even happen. Councillor Gamble agreed to take the points back and see if a more efficient reporting method could be investigated so it was clearer for recipients.

He reported that the Parish Steward scheme was proving very successful this was endorsed by the Chairman, Councillor Jonik and it was agreed that an email from the Parish Council would be write and thank the Erlestoke Parish Steward for his diligence.

#### 296/17 ERELSTOKE WOODS

Councillor Lewcock reported that the trees need some attention and the ivy growth needs to be trimmed. It was agreed that quotes should be sought from contractors and Councillor Lewcock would have the trees assessed by contractors and the Parish Council would select a suitable contractor following submission of quotations. Councillor Lewcock would report back at the next meeting.

#### 297/17 GEORGE AND DRAGON PUBLIC HOUSE

Councillor Lewcock the Parish Council representative and Chairman of The Hub read out the following statement.

The sign on our 250-year-old Pub now reads The 'eorge and Dragon' a symptom of the determination of the owners, Kismet Katering Ltd to turn a profit from our 300 year old pub by turning it into a private house. How long will it be before the sign drops off altogether?

In March 2015, nearly three years ago Erlestoke Parish Council nominated the G&D as an Asset of Community Value (ACV). Since then the owners have had their application to turn it into a private house refused by Wiltshire Council. The Pub has now been up for sale since the spring of 2014, three months after opening, however the owners have ignored four reasonable offers to buy the pub from the Erlestoke Hub, a 'not-for-profit' community benefit society set up by villagers. They have also, in the last few months, received a 100% cash offer at the full asking price from a Wiltshire family who were excited at the real potential of the Pub.

When the prospective purchasers received no response to their offer they asked the owners what price they were willing to accept but, as with all the other offers, the owners simply ignored them and then took the Pub off the market leaving everybody frustrated and mystified.

The former agents for the pub, Sydney Phillips can confirm that there had been plenty of interest from other buyers. An email was received from another Wiltshire resident who was simply discouraged by the owner's strange demands and prevarication and had to drop out.

The owners have always put hurdles in the way of prospective purchasers, such as asking for all sorts of inappropriate information including CV's, cashflow forecasts and business plans. In addition, they have proposed unreasonable covenants and given potential purchasers negative feedback about the village claiming that villagers were responsible for their failed business.

They have never attempted any negotiations – which confirms our belief that they never had any intention of selling the G&D as a pub.

(This is not the first time that the owners have tried to exploit an important community asset. They bought a hotel in a World Heritage site and tried to develop the site as 20 houses leading to significant objections from the local community and local Parish Council. Needless to say their application was turned down as 'mediocre, an overdevelopment, entirely inappropriate, unsympathetic, out of context and would significantly distract from the appearance and character of a conservation area'.)

The George & Dragon remains a pub and an Asset of Community Value, albeit now closed but the Hub continues its efforts to retain it for the community. It's clear that the owners are only interested in making a profit, at the expense of our community, and, if they had managed to turn it into a house, they would now have been long gone. They may attempt another 'change of use' application but having turned down several excellent offers to buy the pub from people, who are happy to work hard to achieve its potential, it is very unlikely they will have any success.

They will have to put it back on the market for a period of six months and try to demonstrate that the Pub cannot be sold to comply with Wiltshire Council's core strategies.

I have asked the owners if they would be willing to meet to see if there is a way to break the stalemate but without success.

I hope the Parish Council will continue to support local efforts to help return the Pub to its original purpose serving the community.
