Assistant Governor Matt Rollings, Head of Residence and Services at HMP, joined the meeting and answered several questions. A key issue was speeding through the village by prison officers and their conduct when approached about their speeding. A/Governor Rollings assured the Parish Council that if an employee was identified the issue would be addressed and the person spoken to. They will also send a Governor's order out to staff. It was advised that details were needed to act on and it was recommended to note the employee of HMP's identification number on their uniform or their registration plate.

Erlestoke Parish Council were very grateful for Assistant Governor Matt Rollings taking the time to join the parish meeting to discuss concerns.

500/22 REPORT FROM COUNCILLOR TAMARA REAY – WILTSHIRE COUNCIL

Councillor Tamara Reay shared with the meeting that Wiltshire council are bringing forward the cost-of-living interventions. The announcements will made on Thursday 9<sup>th</sup> September and a paper that details plans will be sent to Wiltshire Council on Tuesday 14<sup>th</sup> September. They are looking at support mechanisms through the winter such as warm havens.

There is a strong focus on electric vehicles and encouraging town and parishes to provide plug ins. There is a Webinar planned on how to join this initiative.

The Ukrainian settlement scheme is coming to the end of the six months of the initial guests that joined families in the area. Currently there are structural issues with where these guests will move on to next.

Strategy is being implemented in Devizes to tackle anti-social and criminal behaviour. A key scheme is the 'Roots and Shoots' programme to re-engage disengaged youths through the FA and football at the FA centre in Green Lane.

Councillor Reay advised the council that Wiltshire Council are keen on community speed watch teams being active so that they can gather data to collate where there are hot spots for speeding. Erlestoke Parish council are looking into setting up a Community Speed Watch Team and are canvassing interest. Please do get in contact by speaking to a Councillor or emailing Erlestokepc@gmail.com.
